Single Family

All Other

Payment of the permit deposit, grading permit plan review fee (if applicable), and fire sprinkler plan review fee (if applicable) is required at the time of application. At the time the permit is issued, the permit deposit will be applied to the balance of the permit fee, minus the building permit plan review fee shown above. If the plans are withdrawn prior to permit issuance and after the Village has begun plan review, the entire permit deposit, grading permit plan review fee (if applicable), and fire sprinkler plan review fee (if applicable) will be retained by the Village.

**Base Building Permit Fee** \$19.00 for every \$1,000 of the estimated value of the job

**Grading Permit** – new homes, buildings and structures except detached garages \$222.00

**Grading Permit** – all other projects \$113.00

**Grading Permit** – re-review \$80.00

**Inspection and Re-Inspection** \$37.00 each

**Right-of-Way Protection Deposit**

New construction, additions, detached garages, swimming pools \$1,000 refundable deposit

All permits except fence, roof, dumpster, portable storage container, and grading permits are valid for 12 months from the date of issuance. An **18-month permit** may be purchased upon payment of **150% of the 12-month permit fee, at the time of issuance.**

<b>Building Permit Extension</b>	100% of original permit fee
<b>Grading Permit Extension</b>	\$64.00

**Surcharge for performing construction work without the necessary permit**  
 \$144.00 or 50% of the cost of the permit, whichever is greater

### Demolition

Principal structure	\$2,127.00
Accessory structure and underground storage tank removal	\$37.00

### Construction Water Charge

From \$1,000 to \$500,000 value	\$1.43 per every \$1,000 of the estimated value of the job	
Additional charge over \$500,000 value	\$0.74 per every \$1,000 of the estimated value of the job

Base mechanical fee	\$42.00
Ceiling outlet, wall outlet, switch or receptacle add an additional	\$1.08 each
Service installations of:    100 AMP	\$32.00

Air conditioner	\$37.00 per unit

Water meters (separate permit required)	Village cost + \$42.00
Water taps (separate permit required)	Village cost + \$42.00
Pavement degradation fee (for street openings)	Based on condition of street and size of excavation

Plan examination	\$128.00
Initial inspection and any reinspection	\$74.00 each
For all elevators, escalators, dumbwaiters, docklifts, wheelchair lifts, etc.	\$19.00 per \$1,000 valuation

<b>Fence Permit</b>	\$37.00
<b>Portable Storage Unit Permit</b>	\$42.00
<b>Right-of-Way Permit</b>	\$59.00 permit fee and \$1,000 refundable deposit
<b>Roof Permit</b>	\$37.00
<b>Tent Permit</b>	\$74.00
<b>Tree Removal Permit</b>	\$27.00 per tree
