

ORDINANCE NO. 2011-O-11

**AN ORDINANCE AMENDING CHAPTER 2 OF THE WILMETTE
VILLAGE CODE OF 1993**

(Sections 2-16.5 Housing Commission)

WHEREAS, the Village President and Board of Trustees (collectively “Village Board”) of the Village of Wilmette, Cook County, Illinois (“Village”), find that the Village is a home rule municipal corporation as provided in Article VII, Section 6 of the 1970 Constitution of the State of Illinois and, pursuant to said constitutional authority, may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals and welfare;

WHEREAS, the Village Board has the authority to amend the number of members appointed to the Housing Commission and has determined it is in the best interest of the Village to make said amendment; and,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES of the Village of Wilmette, Cook County, Illinois:

SECTION 1: Section 2-16.5.1 of the Wilmette Village Code, 1993 (“Village Code”), as amended, is hereby further amended by deleting the text shown in strikethrough and inserting the new text shown in underlined bold type below as follows:

2-16.5 HOUSING COMMISSION.

2-16.5.1 CREATION.

There is hereby established a Housing Commission which shall consist of **five** ~~seven~~ members, who shall be citizens and residents of the village.

SECTION 2: Section 2-16.5.4(a) of the Wilmette Village Code, 1993 (“Village Code”), as amended, is hereby further amended by deleting the text shown in strikethrough and inserting the new text shown in underlined bold type below as follows:

2-16.5.4 APPOINTMENT; TERM OF OFFICE; COMPOSITION.

(a) The **five** ~~seven~~ members shall be appointed by the Village President with the advice and consent of the Board of Trustees for a term of three years.

SECTION 3: Section 2-16.5.5(b) of the Wilmette Village Code, 1993 (“Village Code”), as amended, is hereby further amended by deleting the text shown in strikethrough and inserting the new text shown in underlined bold type below as follows:

2-16.5.5 QUORUM; RULES; QUALIFICATIONS.

(b) **Three** ~~Four~~ regular members of the Commission shall constitute a quorum, and any action or recommendation shall require the affirmative vote of at least **three** ~~four~~ members.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
