Re: 2023 Pavement Rejuvenation Program

Dear Wilmette Resident:

We are pleased to inform you that your block will be part of the 2023 Pavement Rejuvenation Program!

Rejuvenation is a preventative maintenance procedure aimed at extending the service life of asphalt streets. This program involves applying a maltene-based product onto the surface of the pavement, which will help reduce water penetration and limit asphalt oxidation. Unlike seal coating, this process is intended to be a one-time application, and is typically applied within two years after paving the street.



This letter serves as a preliminary notice for this work. The Contractor will deliver a second notice to your door at least one day in advance of the application. In the meantime, please review the reverse side of this sheet for additional project details.

Schedule

This project is expected to start as early as **Tuesday, August 1, 2023**, weather permitting. The work should take approximately two to three business days to complete. Please be aware that the work may be intermittent at times as the crews could be working on other streets in the Village.

The Contractor will deliver a notice to your door at least one day prior to the start of work. "No Parking" signs will also be posted on the street at least one day in advance of the application. If the forecast calls for rain, please expect the work to resume on the next business day, unless otherwise notified by the Village or Contractor.

Garage and Street Access

Access to the street and your garage will be maintained throughout the project, apart from brief interruptions caused by the Contractor's equipment. If the crew is working on your street, please drive slowly and stay on sanded areas.

Emergency, Mail, Refuse and Recycling Pickup

All services will be maintained throughout the project.

Clean up

Once the product is applied to the pavement, the Contractor will spread a sand mix onto the pavement surface. These screenings will help prevent vehicles from tracking the product onto other streets and driveways. The Contractor will sweep up this sand mix about 24 to 48 hours after the product application.
