**Permit Deposits and Plan Examination Fees – Due at Application**

Single Family

Fire sprinkler system	\$109.00 plus cost of consultant review

All Other

Fire Chief/Fire Prevention Bureau review	\$169.00 plus cost of consultant review

Payment of the permit deposit, grading permit plan review fee (if applicable), and fire sprinkler plan review fee (if applicable) is required at the time of application. At the time the permit is issued, the permit deposit will be applied to the balance of the permit fee, minus the building permit plan review fee shown above. If the plans are withdrawn prior to permit issuance and after the Village has begun plan review, the entire permit deposit, grading permit plan review fee (if applicable), and fire sprinkler plan review fee (if applicable) will be retained by the Village.

**Base Building Permit Fee** \$20.16 for every \$1,000 of the estimated value of the job

**Grading Permit** – new homes, buildings and structures except detached garages \$235.00

**Grading Permit** – all other projects \$120.00

**Grading Permit** – re-review \$80.00

**Inspection and Re-Inspection** \$39.00 each

**Right-of-Way Protection Deposit**

New construction, additions, detached garages, swimming pools \$1,000 refundable deposit

All permits except fence, roof, dumpster, portable storage container, and grading permits are valid for 12 months from the date of issuance. Building permits may be extended at a cost of 1/12 of the original permit fee for each 30 days after the original expiration date.

<b>Grading Permit Extension</b>	\$68.00

**Surcharge for performing construction work without the necessary permit**  
 \$153.00 or 50% of the cost of the permit, whichever is greater

Accessory structure and underground storage tank removal	\$39.00

Base electrical fee	\$45.00
Base mechanical fee	\$45.00
Ceiling outlet, wall outlet, switch or receptacle add an additional	\$1.15 each
Service installations of:     100 AMP	\$34.00
200 AMP	\$45.00
400 AMP	\$62.00
per hundred AMP over 400 AMP add	\$45.00
Air conditioner	\$39.00 per unit

### Plumbing Permit Fees

Base plumbing fee	\$45.00
Fixtures, including water heater, water closets, etc	\$8.00 each
Lawn sprinkler base fee	\$68.00
Water meters (separate permit required)	Village cost + \$45.00
Water taps (separate permit required)	Village cost + \$45.00
Pavement degradation fee (for street openings)	Based on condition of street and size of excavation

### Unmetered Water

When a service address is not equipped with a water meter, including water service for construction activities temporarily supplied, the water customer will be billed a flat rate of \$5.15 per day on their water bill.

For all elevators, escalators, dumbwaiters, docklifts, wheelchair lifts, etc.	\$20.16 per \$1,000 valuation

<b>Roof Permit</b>	\$39.00
<b>Tent Permit</b>	\$79.00
<b>Tree Removal Permit</b>	\$29.00 per tree
