1. Please provide all requested information.
2. If you do not know the specific information concerning your alarm system, please contact your alarm monitoring company or alarm installer to obtain it.
3. Send completed application along with the initial application fee of \$15.00, made payable to the Village of Wilmette, to: Attention: Alarm Permit, Wilmette Police Department, 710 Ridge Rd., Wilmette, IL 60091. Your cancelled check will serve as your permit confirmation.

ALARM USER PERMIT APPLICATION

No person, firm, corporation, or other organization shall use, own, lease, or control an alarm at any residence, building or other structure or premises with a fixed location within the Village without obtaining a permit from the Village for registration thereof.

The following statements are made by me for the purpose of obtaining this permit and I certify to its truth. I agree to conform with Chapter 5, Section 6 of the Village of Wilmette Code.

I agree that the Village shall not be liable for any failure of service or any damage that might result from the installation or operation of, or response to, the Alarm.

I agree to pay all charges and fees payable under Chapter 5, Section 6 by reason of the operation of the Alarm and all costs and expenses of the Village in collecting such charges and fees, including court costs and attorney's fees.

PLEASE PROVIDE ALL REQUESTED INFORMATION. INCOMPLETE APPLICATIONS SHALL BE RETURNED TO THE APPLICANT.

A PERMIT WILL NOT BE ISSUED UNTIL THE COMPLETED APPLICATION IS RECEIVED AND THE ALARM ADMINISTRATOR HAS GRANTED APPROVAL FOR THE PERMIT. PLEASE TYPE OR PRINT ALL INFORMATION.
