1. This Contract Extension is made by the Village of Wilmette ("Village") and Thompson Elevator Inspection Service, Inc. ("Contractor"), Parties to Contract No. 19018 – Elevator Inspection Services ("Agreement" or "Contract").
2. For and in consideration of the mutual covenants and promises contained in this Contract Extension and other good and valuable consideration, the sufficiency of which is hereby acknowledged, the Village and Contractor hereto agree to the following:
 - a. The Parties agree to renew the Agreement for four (4) years commencing upon the final party's execution of this Contract Extension. The new Contract Term will begin on January 1, 2020 and end on December 31, 2023.
 - b. The total compensation to the Contractor shall be based upon the actual amount of work performed multiplied by the applicable fee amount in Attachment One to the Agreement (2019 prices).
3. This Contract Extension No. 01 is incorporated into the Agreement and shall not be effective unless this Amendment is also executed by the Parties.
4. Except as set forth in this Contract Extension, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms. If there is conflict between this amendment and the Agreement or any earlier amendment, the terms of this amendment will prevail.

5. The Agreement shall be binding on the parties and effective only as of the date fully executed by both parties.
