This Contract Amendment is made by the Village of Wilmette ("Village") and Lucas Landscape and Design Co ("Contractor"), Parties to Contract No. 170021 Parkway Tree Pruning ("Agreement" or "Contract) as amended by Amendment No. 01 dated January 11, 2019 and approved by the Village Board on January 22, 2019; and as amended by Amendment No. 02 dated November 14, 2020 and approved by the Village Board on November 10, 2020.
- 2. For and in consideration of the following Unit Prices Per Inch for Routine Parkway Tree Pruning and other good and valuable consideration, the sufficiency of which is hereby acknowledged, the Village and Contractor hereto agree to extend the termination date for the above referenced Contract from December 31, 2021 to December 31, 2023 at the following unit rates:

- 3. This Contract Amendment No. 03 is incorporated into the Agreement and shall not be effective unless this Contract Amendment is also executed by the Parties.
- 4. Except as set forth in this Contract Amendment, the Agreement and earlier Contract Amendments are unaffected and shall continue in full force and effect in accordance with their terms. If there is conflict between this Contract Amendment and the Agreement or any earlier Contract Amendment, the terms of this Contract Amendment will prevail.

5. This Contract Amendment shall be binding on the parties and effective only as of the date fully executed by both parties.
